### Veteran Healthcare Enrollment Program

ASPIN's Veteran Healthcare Enrollment Program (AVHEP) focuses on utilizing experienced navigators dually trained as community health workers to:

- Assist veterans and their families in understanding healthcare program options in and out of military connected systems
- Provide education on health insurance programs on the Federal Marketplace or through state Medicaid and CHIP
- Increase healthcare enrollment of uninsured veterans and their families in Indiana.



### Healthcare Marketplace

The Healthcare Marketplace provides tools for consumers to compare health insurance plans, learn about assistance in paying for coverage, or choose a health insurance plan.

Consumers are able to choose or change health plans during the Open Enrollment Period or at other times if they experience life changes or events known as "Special Enrollment Periods" (SEP). Examples of SEPs include changes affecting: your family size/household; coverage available to you; your household income; citizenship/immigration status; and incarceration status.

#### Coverage Choices for Veterans and Families

Depending on household size and income, you may get lower rates on monthly premiums and/or out-of-pocket costs.

You could be eligible for free or low-cost coverage through Medicaid or CHIP.

#### The Healthy Indiana Plans:

<u>HIP 2.0</u>: Provides health coverage available to low-



income adults ages 19-64 who are not eligible for Medicare or Medicaid.

<u>HIP Plus</u>: Includes dental and vision, and no co-pays except for non-emergency ER visits. A monthly contribution to your POWER Account is required.

<u>HIP Basic:</u> Option for those with income less than 100% Federal Poverty Level (FPL) who do not make their POWER Account contributions. The plan does not include dental and vision; and copayments are required for services such as doctor visits, and prescriptions.

**CHIP:** The Children's Health Insurance Program (CHIP): Offers free or low cost health insurance for children and teens up to age 18.
